The Trustees by fulfilling the requirement is/are successfully running the said school uptill this date. Now the name, fame and reputation of the said institution '**EDUCARE INTERNATIONAL SCHOOL**' is outspread all over the West Bengal.

That for some personal inconveniences one member of the Trust namely Dilip Ratan Bhattacharjee did not wanted to hold the post as Member of the said managing Trustees and for that he had resigned from the said Trust namely 'Madhusudan Educational Charitable and Welfare Trust'. That the other members

being the Managing Trustees of the said Trust accepted his resignation and the other Trustees had been continuing with the objectives, liabilities and responsibilities of the said Trust. Be it mentioned that subsequently said Dilip Ratan Bhattacharjee died few years ago.

That due to personal inconveniences the outgoing members of the Trust namely Mr Radhaballav De and Mr Samarjit Ghosh did not wanted to hold the post as Member(s) of the said managing Trustees, instead they had resigned from the said Trust namely 'Madhusudan Educational Charitable and Welfare Trust'.

That on the other hand the incoming / admitting Member(s) namely Mr. Dibash Karmakar is being admitted as the new Member amongst the Managing Trustees of the said Trust and he shall hold the post of Treasurer as well as Member of the said Trust.

That all the members of the said Trust including the outgoing/Resigning Members amongst the Trustees jointly and unanimously had taken a Resolution dated 12/12/2022 accepting the Resignation of the outgoing Members and similarly induction / inclusion the incoming / Admitting Members as the Managing Trustees of the said Trust.

NOW THIS DEED WITNESSETH as follows :

W H E R E A S on and from 12/12/2022 the said outgoing members namely Mr Radhaballav De and Mr Samarjit Ghosh are not the part / member(s) of the said 'Madhusudan Educational Charitable and Welfare Trust' and shall not be responsible and liable and accountable in any manner whatsoever for the said Trust as the Managing Trustees. The present Trustees have no claim, demand etc in any manner whatsoever against the said outgoing/resigning members/Trustees.

AND WHEREAS on and from 12/01/2023 said incoming/Admitting Member namely Mr Dibash Karmakar shall hold the Post of Treasurer shall be designated as the Member of the Managing Trustees of the said Trust.

That two Members i.e. the Chairman - Mr Bikash Karmakar and any one between the Secretary - Mrs Rubita Karmakar or the Treasurer - Mr Dibash Karmakar shall entitle to manage and operate the Bank Account(s) in the name of the '**Madhusudan Educational Charitable and Welfare Trust**' as also shall issue Cheque(s) in favour of the secure Creditor(s) on behalf of the said Trust. That for any act or works of the Trust the Chairman shall jointly subscribe his signature together with either the Secretary or the Treasurer.

That the continuing including the admitting Trustees shall be responsible, liable and accountable for all liabilities and responsibilities and its day to day affairs and activities of the said Trust.

That if any Member(s) shall resign from the Managing Trustee(s), in that event the Chairman after complying all the regulations and formalities shall call for meeting of the Managing Trustees and shall be taken resolution either for acceptance and/or refusal of the said Resignation.

AND WHEREAS the Settlor and the Members of the Managing Trustees of the trust namely '**Madhusudan Educational Charitable and Welfare Trust**' shall continue and/or fulfill the objects and purposes.





